

# 2021 LIVE UNITED - GIVE UNITED Sweepstakes Rules

**1. TIMING:** This incentive promotion includes 2021 United Way of Portage County (UWPC) Campaign donations made through 5 p.m. Central Time on Thursday, Nov. 18, 2021. Prize winners of any prizes offering "winner's choice" must provide Sweepstakes Sponsor their prize selection within ten (10) days of date of issuance of prize notification on December 8, 2021. To be eligible for the **2021 LIVE UNITED - GIVE UNITED (LUGU) Sweepstakes**, participants must be legal residents of Wisconsin, at least 18 years of age, AND possess a valid Wisconsin driver license.

**3. ELIGIBILITY:** Employees of UWPC and their immediate families are not eligible to participate. Only individuals/ families are eligible for the LUGU Sweepstakes; organizations are not eligible. Out of area campaigns that are processed by, but not counted toward the UWPC campaign are not eligible. Designated donations to United Way of Portage County from other United Way campaigns are eligible. Online entries will not be accepted. A limit of ONE HUNDRED entries per person, automatic or otherwise, allowed for the LUGU Sweepstakes.

- Any UWPC donor (*exclusive of any employer match*) that:
  - gives a first-time gift of \$104 or more in 2021 OR an increase of at least \$52 over their 2020 campaign gift of \$52 or more will be automatically entered into the LUGU Sweepstakes for **ONE HUNDRED chances to win**.
  - gives a first-time gift of \$52 to \$103.99 in 2021 or gave \$52 or more in 2020 and continues to give \$52 or more in 2021 (*but less than a \$52 increase*) will be automatically entered into the LUGU Sweepstakes for **FIFTY chances to win**.
- Entry without donation for the LUGU Sweepstakes can be made by mailing (*US Postal Service only*), up to 100 entries on 4"x6" cards (*10 entries per envelope*) to United Way of Portage County, ATTN: LUGU Sweepstakes, 1100 Centerpoint Drive #302, Stevens Point, WI 54481, containing name, address and phone number. No other alternate methods of entry or entry delivery are eligible.

**4. ENTRIES:** Entry letters must be postmarked AND pledge forms, eligible donations and eligible employee lists must be received by UWPC by 5 p.m. Central Time on Thursday, November 18, 2021. UWPC will not be responsible for individuals, companies or other United Way organizations that fail to submit their employee pledge forms, eligible donations, designated gifts or list of eligible employees by this date. UWPC is not responsible for lost or misdirected mail.

**5. DRAWING & ANNOUNCEMENT:** LUGU Sweepstakes qualifiers will be drawn randomly by December 8, 2021, at the UWPC office. Nine qualifiers and nine alternate qualifiers will be drawn for the LUGU Sweepstakes. One eligible qualifier allowed per LUGU entrant. If the potential qualifier does not meet the stated eligibility requirements or is not in compliance with these Official Rules, the potential qualifier will be disqualified and an alternate qualifier (*in the order they were pulled*) will be selected. The nine eligible LUGU Sweepstakes qualifiers will then be randomly chosen and announced as Grand Prize, First Prize, Second Prize, Third Prize, Fourth Prize, Fifth Prize, Sixth Prize, Seventh Prize, and Eighth Prize winners at the UWPC - Campaign Victory Celebration on Wednesday, December 8, 2021, in Stevens Point. Those names are added to the database of automatic qualifiers. Additionally, those people who submitted an entry outside of the automatic qualification process are also entered into the database. Although we cannot publish the list of all those who qualify, if a workplace campaign requests a list of qualifiers from their own company, UWPC can provide it prior to the drawing, but after all pledges received by November 18, 2021, have been posted.
