THE DIAPER DRIVE PROGRAM FILLS A NEED MANY LOCAL AGENCIES IDENTIFIED AS A TOP ISSUE FACING STRUGGLING FAMILIES-NOT BEING ABLE TO PROVIDE THEIR CHILDREN WITH DIAPERS. THIS CAN OFTEN RESULT IN HEALTH ISSUES FOR INFANTS AND TODDLERS WHOSE DIAPERS ARE NOT CHANGED AS FREQUENTLY AS THEY SHOULD.
